Call to Order – Gail Hillard, President at 7:25 p.m. (Quorum not in attendance at 7:00 p.m.)

Secretary's Report: Ann Byrne, on behalf of Tammy Selka

Minutes: Review of January and March BOD minutes – no corrections or amendments;

Both sets of minutes approved and passed – Motion by Ann Byrne; Second by Deb Eckert.

Correspondence:

1. LKC received an invitation to put on a "Meet the Breeds" at Mt. Hope Nazarene Retirement Community in Manheim at the club's convenience.
2. LKC has been invited to participate at "Bark in the Park" at the Nottingham County Park on October 1 2011 by the Chester County Parks and Recreation Department.
3. There was not action taken on correspondence items.

New Members

1. Final reading of membership applications from Sharon Shirk, Judy Kramarich, and Anthony and Judith Spurigo. Motion to move vote to full membership at June 8, 2011 made by Hank Hillard, Seconded by Deb Eckert. Motion passed.
2. New Member Application was received from Stephanie Herr, sponsored by Tammy Selka and Ann Byrne.

Treasurer's Report: Ann Byrne

1. Financial Statement for April, 2011 was reviewed. Motion to approve made by Sue Tomlinson, Second by Deb Eckert; motion carried.
2. Rain Insurance – Investigation was made into "Rain Insurance" in consideration of the flooding that occurred at the Harrisburg show. Cost of the insurance is prohibitive and it was decided that the "Chairs" of the shows and trials should negotiate contract clauses to protect the club from loss of income due to "acts of God" and other man-made events which would preclude the club from holding the event.
3. Accounting Firm – Ann asked whether the Board would approve the continued use of Wenger & Company for the annual tax filing and financial compilation. Chad Wenger advised that with the IRS requiring the club to e-file the tax return, he projected the cost to be between \$450 and \$800 this year. Ann advised that the financial and tax information will be made available to Wenger & Company shortly after the end of the fiscal year to allow the new Treasurer to begin with a clean slate. Board approved, by voice vote, the continued use of Wenger & Company. Hank Hillard moved to continue to use Wenger & Company; seconded by Sue Tomlinson; motion passed.

AKC Delegate Report: Cindy Garman was absent. No report.

Committee/Events Reports:

1. **Point Shows:** CathyAnn Litwin absent. Gail reported that the Red Ross Classic Show went well and she was pleased with the increase in attendance and entries. No report on the report on the Celtic Classic. Ann noted that all bills and reimbursements were not yet complete.
2. **Agility Trial:** Hank Hillard reported that there is a possible future conflict with the regional Gordon Setter Club next year.
3. **Constitution and By-Laws:** Chair Sue Bullitt presented a petition signed by 35 club members to the acting Secretary. The petition requests that the Board of Directors move the proposed Constitution and By-Law changes to the full membership for a vote. According to the current Constitution and By-Laws, the Board of Directors now has 90 days from May 2, 2011 to present the proposed changes to the full membership. President Hillard scheduled a special board meeting to go over the changes for Monday, May 16, to be held at the residence of Peter and Ann Byrne beginning at 7:00 p.m... The secretary was requested to publicize the special board meeting in compliance with current by-laws.
4. **Nominating Committee:** Pete Byrne reported that there are four candidates for the Board of Directors – Sue Bullitt, Debby Bush, Trish Hillegas, and RainBear Mahoney. Candidate's bios were sent to the Secretary for inclusion in the newsletter.
5. **Scholarships** – Joy Ellwanger. In the absence of Joy, Hank Hillard reported that the Scholarship Committee has selected two veterinary students and four vet techs to receive scholarships because no scholarships were awarded in 2010. Discussion ensued as to the merits of making six scholarship awards. It was decided that the Scholarship Committee should make available copies of the individual resumes with their recommendations for three scholarships. A special Board Meeting was called for 12:00 p.m. on Sunday, May 15, 2011 during the ring breaks at the Red Rose Classic to discuss the scholarships with all board members in attendance.
6. **Other Committee/Event Reports:**
Discussion of future Pet Expo at convention center. Sue Tomlinson indicated she would chair again this year. Deb Eckert reported that we received the check for \$250.00 from the "Shop for a Cause" event. Discussion was held about inviting Cpl Bolton to the Red Rose Classic for a check presentation but was decided against because it is out of the county. We are trying to get a publicity article with a picture of the presentation in the local newspaper. No date for the check presentation has been set.

Unfinished Business: Ann presented a list of unfinished business at the request of the Secretary.

1. Did we do Pet Days at funeral home? Gail responded that no one was available to chair event.
2. By-Laws – see discussion above with Committee presentation of a signed petition.
3. Microchip Clinic – None scheduled – could possibly be done at a Health Clinic, or free-standing – no decision was made. Discussion on whether to offer micro-chipping at the Pet Expo at the convention center. No decision.
4. Awards Banquet – Ann and Tammy working on it – scheduled for Wednesday, June 8 at the Lancaster Leiderkranz. Menu being finalized and reservation form is being prepared.
5. Furever Home Rescue – did they purchase microchips? No.
6. General Membership – Supporting local K9 units – discussion was conducted and unanimously voted that the Membership Renewal Forms will delete contributions to the Canine Health Foundation and instead allow members to elect to donate additional funds to "local support" of Cpl. Bolton and Ronin and the Means and their SAR team.
7. RDOD – No one has stepped forward. Ann and Pete Byrne did last year and will assist but not chair. Discussion to include "chipping" clinic which would depend on location. Need to find a chair for this year. Discussion whether to ask AKC whether we can incorporate this event into the Pet Expo held in December since they allowed us to hold an RDOD in October with the Lebanon Kennel Club. No decision yet – Sue Tomlinson to contact to AKC need to see if we could hold it at the Pet Expo.
8. Volunteer Recognition – No report. Cat Litwin was not present.

9. Eye Clinic – Discussion of whether this should be incorporated into a larger health clinic. Who was to chair? Health clinic could be for eye, heart, and micro-chipping. No one has contacted the chair to ask on committee activity.
10. CGC Evaluator – Tammy previously proposed that the club support member (Deb Radanovic) in her courses and necessary hours to achieve the evaluator certification. It was discussed and approved with voice vote that the LKC will support Deb monetarily in her endeavor for the good of the club.
11. Speakers – are any speakers scheduled for the remainder of the year – two are needed per year. Discussed whether a member of CART could speak at the June meeting – Hank to investigate.
12. Picnic – Event scheduled for Long's Park – pavilion is rented for Sunday, August 14, 2011.

New Business: None.

Adjournment – Ann Byrne moved that the meeting be adjourned; Sue Tomlinson seconded. Motion carried and the meeting was adjourned at 8:45 p.m.

 0. Life membership is granted in recognition of the exceptional service and support provided by the proposed member of the club. Life members are exempt from the payment of dues. Life membership may be proposed by any two members of the Club in good standing. All proposals are to be filed with the Secretary; each proposal is to be read at the next Board meeting.
