Sometimes you wish dog shows weren't all day events. This being my first show where all the responsibility falls on me, I wanted to get a head start. #### **Of Interest:**

#### Some Thoughts on Glucosamine and Chondroitin and Pet Food

As of late, many pet food manufacturers have chosen to include glucosamine and chondroitin in their commercial food preparations. While many may think this an altruistic move on the part of these manufacturers, the decision to include these ingredients has much more to do with increasing product sales and product/brand differentiation than most companies would care to admit. Focus groups, following trends in the human food and nutraceutical category, and the difficulty of marketing parity products have all played a much more significant role than the desire to save the world from canine arthritis. Make no mistake, the pet food industry is big business and, as such, is motivated by the bottom line, profit margins, and just plain making a buck - something clearly demonstrated last year by the Pet Food Recall and the use of inferior foreign ingredients in attempt to keep costs as low as possible to increase their ROI (return on investment).

Contrary to what many believe, there have been several studies completed on the efficacy of Glucosamine and Chondroitin given various types of administration - orally as a supplement, as a treat standardized as to dosage, and as additive to pet food. The best overall methodology is seen in the study conducted by Tiffany Linn Bierer and Linh M.Nui which was published in The America Society for Nutritional Sciences in June 2002 and is entitled "Improvement of Arthritic Signs in Dogs Fed Green-Lipped Mussel (*Perna canaliculus*)."

Now I know you are thinking "Green Lipped Mussels? What the heck do they have to do with glucosamine and chondroitin?" The answer is ... everything! These very large (by mussel standards!) New Zealand bi-valve mollusks are one of the riches sources of naturally occurring Glycosaminoglycans (GAGS) which are, in turn, a major component of joint cartilage.. Glucosamine, an amino sugar, is a precursor for Glycosaminoglycans. Chondroitin is actually a variable chain of alternating sugars and a true GAG along with things like Dermatan and Heparin. Ok, so back to the study ...

Bierer and Nui used a total of 90 dogs divided as follows:

Study 1 - Green Lipped Mussel used as a supplement and in addition to regular dog food as dosed by weight. For this portion of the Study, 15 dogs were in the Control Group and 17 received Supplementation.

Study 2 - Green Lipped Mussel incorporated in a semi-moist treat and given in addition to regular dog food again by weight. This portion of the Study consisted of 16 dogs in the Control Group and 17 the receiving the treat.

Study 3 - This group was fed the regular dog food formulation used with the other two groups with the addition of Green Lipped Mussel added during the manufacturing process with a final inclusion level of .3%. The Control Group consisted of 17 dogs while 14 received the Green Lipped Mussel as manufactured component of their main meal in accord with standard feeding practices in respect to maintenance of over-all condition. (Actually, WALTHAM<sup>®</sup> Veterinary Diet Canine Joint Support - a prescriptive - was used.) All dogs in the study were followed for 6 weeks. The results were as follows: Study 1 - 83% (14 of the 17 dogs) receiving Green Lipped Mussel as a supplement dosed by weight and in addition to regular dog food saw a 30% or better reduction in total

arthritic scores. Three dogs actually saw a 70% improvement.

Study 2 - 53% (9 of 17 dogs) receiving the semi-most treat saw a 30% or better reduction in total arthritic scores.

Study 3 - 50% (7 of 14 dogs) receiving Green Lipped Mussel as part of their daily processed diet saw a 30% or better reduction in total arthritic scores.

The Bierer and Nui Study clearly indicates that the most efficient and effective means of dosing is by weight and in supplement form. But it also raises a not so obvious consideration. As a standardized prescriptive diet was used to judge efficacy of Green Lipped Muscle inclusion in the main meal, can we conclude that commercially available diets containing GAGS, though less effective than supplementation, will be equally as effective as the prescriptive? The answer, of course, is no - and this due to the fact that there is no overseeing authority to hold the commercial pet food companies to a standardized inclusion level of novel pet food ingredients. With the prescriptives there is oversight - albeit mostly provider driven.

While not mentioned in this Study, but also of concern, are the potential side effects of using Glucosamine and Chondroitin as a pet food additive. Derived from shell fish, it can exacerbate allergic reactions in those dogs that have sensitivities. Further, because Glucosamine is an amino sugar, it can cause fluctuations in insulin levels and thus become create problems in dogs with diabetes. A real possibility when used as a main food additive is over-dosing as in the case where, due to activity level, an individual animal requires much more in food to maintain condition than is stated in the "Feeding Guidelines" which are typically broken down into weight, rather than activity, levels. The symptoms of over dosage are soft stool, diarrhea, and vomiting. Further, as there have been no studies in either man or beast, Glucosamine and Chondroitin should not be given to the in-whelp or lactating bitch.

The conclusion? Supplement with Glucosamine and Chondroitin if you like but, given the possible side effects, do it with your veterinarian's knowledge.
