- 1. Call to Order by President Ann Byrne @ 7:06 PM

- 2. Secretary's Report Dave Martin
  - a. August Minutes. Motion to approve by Jim Bullitt, second by Mary Hartman. Unanimously approved.
  - b. Correspondence Bank related materials and membership renewals.
- 3. Treasurer's Report Sue Bullitt
  - a. Agility Trials looks like it will turn a profit. Not sure of the final amount due to some checks that are still outstanding.
  - b. Boxer trophy CD just matured and was rolled over into a 18 month CD @ 1%. The revenue from this purchases a Boxer trophy for the Red Rose Classic.
  - c. Current Balance \$106,722.42. Motion to approve by Penny Sleeth and second by Deb Eckert. Unanimously approved.
- 4. AKC Delegate's Report Carolyn Vack
  - a. Litter Registrations are down 0.3 % but revenue is up.
  - b. There are now 38 emergency response trailers across the country. The program is still in its first two years.
  - c. One amendment was proposed for a 4-6 Month Puppy Class. A Certificate of Merit would be earned. The point of contention is that a Point would be earned which would mean a dog could earn a point without ever going up against other dogs. General approval but objections to details. Motion was made to send back to Board of Directors.
  - d. At the next meeting, discussion will take place to allow clubs to use e-documents for premium lists, judging programs, and catalogs.
  - e. Discussion on multiple levels for Grand Champion as well as All Breed Clubs. Peewee class is now in place and online training for clubs is available to see how other clubs may have creatively solved common issues. Still discussing territory issues, which has been sent back to Board.
  - f. Hard copy of summary provided for LKC records.
- 5. Committee and Event Reports
  - a. Picnic Ann for Debby Radanovic Thanks for a great picnic Debby!!
  - b. RDOD Ann feels it went well. 13 dogs were microchipped, which is about 4 times the usual amount. 4 dogs earned their CGC. Special thanks again to Debby and to everyone else who was there that day.

- c. Agility Tom Herr Over 600 runs each day. Ran smoothly. There was a dog bite incident outside the facility with a baseball player. The ball went close to a dog, the dog got the ball, and the player got bit when he tried to get the ball back. Issue was resolved. Tom gave Kudos to Mary Lou Strayer on how she handled the situation. Next year, In The Net will have an AED in place due to an incident they had at another event. Discussion ensued about LKC purchasing one and having on hand. Prices will be checked and then further discussion to follow.
- d. Celtic Classic Judges have been selected and premium list is being worked on. We did not have trophies this past year. Looking for volunteers for trophy committee. Deb Eckert, Penny Sleeth and Ann Byrne volunteered as did Sue Bullitt for Obedience and Rally.

  - b. <u>Shop for a Cause:</u> Deb Eckert presented a check to the Red Rose K9 Search and Rescue Team for our fourth place winnings of \$1,500 plus the allocated donations from the membership.

Anna Mary Kauffman was born on October 5, 1918, the daughter of John and Mary Hess, and was raised in Mountville, PA. She married Amos M. Kauffman, whose family lived across the street, in 1940 and they remained married for 65 years. Amos passed away in 2006. Anna Mary passed away at the age of 92 in March, 2011 at her home.

Anna Mary and Amos owned and operated the Dog Shop on Manor Street in Lancaster until their retirement in l981. Anna Mary was a groomer of poodles. Amos would pick up dogs to be groomed at their residences and bring them in to the shop, and after they were groomed, he would deliver them back home. He was a very large man and it was hard for him to do the little poodles, since his hands were so big, so it became Anna Mary's job to groom the little dogs. It was not her favorite thing to do!

Amos and Anna Mary were avid breeders of championship Great Danes. Mountdania Kennels was well known among breeders of Great Danes for over forty years. They had some top Danes in the breed ring. After they no longer bred Danes, she became an American Kennel Club judge of Great Danes, which allowed her to travel all over the world, judging in Australia, England, and Finland, to name a few places.

The Kauffmans were members of the Great Dane Club of America, as well as founding members of the Great Dane Club of Central Pennsylvania and founding members of the Lancaster Kennel Club. Great Danes were their passion. The Great Dane became the official state dog of Pennsylvania in 1965, thanks to the successful lobbying led by Anna Mary.

People would flock to Anna Mary at dog shows, which she loved to attend. She was very well known and was a very humble person despite her popularity. She enjoyed all dog events and accompanied Bobby Dochat to many obedience events with her Danes. She enjoyed coming along with Bobby to agility practice with her Danes "Liz" and "Mandy". Anna Mary thought it was amazing to see the Danes, as well as other breeds, do agility! We enjoyed going out for lunch with Anna Mary at the Hong Kong Garden Chinese restaurant, where she would always order sweet and sour chicken!

Anna Mary owned a Great Dane until the day she died.

### **Keeping Your Dogs Safe During Halloween**

#### **PVMA FACT SHEET**



It's that time again—time to dress up as your favorite super hero, princess or sombie and reap the rewards of the kindness of your neighbors. Halloween is a time for everyone to have fun, feel like a kid, and eat a little extra candy, but Halloween celebrations can pose risks for the family dog. Here are some tips for keeping your pooch safe during Halloween.

If you plan to hand out candy from your home on Trick or Treat night, remember that all the extra doorbell ringing may have

an adverse effect. Depending on the disposition of your dog, excitable kids at the door every few minutes may also add to the stress. Some dogs find the constant commotion frightening and may bolt while you open the front door. Make sure your dog is wearing a collar with contact information for you or your veterinarian. Also, if your dog is microchipped, make sure your registration information is up-to-date. The microchip won't do any good if you can't be reached!

If you plan to have your dog in costume, make sure it fits properly and is not too tight or too loose. It should also not contain decorations that can easily be chewed off and choked on or swallowed. Also make sure the costume doesn't inferere with your pet's senses like seeing and hearing properly. If you're pet can't tolerate the doorbell and the trick or treaters, consider putting them in another room—without their costume.

 $\mbox{\it Jack-o-laterns}$  with burning candles inside them should be kept out of reach of your pet at all times.

When handing out candy from home, be sure to keep the candy you plan to distribute is out of the reach of your dog while waiting for or talking to trick or treaters to arrive. Chocolate is poisonous to dogs, and depending on the size of the dog and the strength of the chocolate, it can cause death. According to the Pet Poison Helpline, in 2010, chocolate consumption among dogs increased more than 200% during Halloween! If your dog has gotten into the chocolate candy, call your veterinarian or the Pet Poison Helpline immediately. The chemical toxicity results in vomiting, diarrhea, hyperactivity, inflammation of the pancreas, an abnormal heart rhythm, seizures, and sometimes, even death. Remember, it's the dose that makes the poison. In smaller dogs, even the wrappers from candy can result in a secondary obstruction in the stomach or intestines.

Chocolate isn't the only Halloween danger. High-sugar, high-fat candies can cause pancreatitis while raisins—sometimes appearing in the candy or handed out instead of candy—are also extremely poisonous to dogs and can cause kidney failure. If your dog has eaten any amount of raisins, grapes, or currants, you should treat it as a potentially toxic situation and immediately call your veterinarian or the Pet Poison Helpline.

If you plan take your dog along while taking your kids trick or treating, make sure you keep them reigned in on a fairly short leash while you're out and about. Even if you have a well-behaved dog, letting them get ahead of you on an extendable leash increases the opportunity that they could trip other children, steal a snack out of someone's treat bag, or gobble up anything that gets dropped.

After trick or treat is over, be sure to store your candy in a spot where

your dog can't reach it.
Some dogs are more determined than others and may
find away to get to it even if
it is high up on the counter.
Keeping it in the refrigerator or in an upper cabinet
or pantry may be a better
solution.

#### NATURAL TREATMENTS FOR YOUR CAR-SICK DOG Shawn Messonnier, DVM, AMERICAN KENNEL CLUB

Car-Sick Canine: Holistic Remedies

A relaxing atmosphere can soothe the anxious canine passenger. There are a few natural remedies that can help a dog prone to car sickness.

Some dogs are susceptible to motion-sickness. Yes, that's hard to imagine after seeing how excited many dogs become at the mere mention of a ride in a car. Motion-sickness drugs are available for the car-sick canine, but dog owners should consider natural alternatives, say holistic veterinarians. Here are a few suggestions:

- Apply a few drops of lavender or chamomile oil to a cotton ball and place it inside the vehicle about 30 minutes before the car ride. This fills the vehicle with a soothing aroma. (Be sure to remove the cotton ball so your dog doesn't eat it!)
- Spray a small amount of Dog Appeasing Pheromone (DAP) inside the car.
- Homeopathic remedies such as nux vomica can be given to settle your dog's stomach.
- Take your dog on short trips to help your pet build a tolerance for longer trips.
- Don't promote your dog's anxiety by limiting car rides to trips to the vet's office.

#### FINDING A "BREEDER'S VET"

Spend enough time talking with dog breeders, and you will hear all sorts of stories—stories about veterinarians who "didn't know anything," about veterinary costs, and about veterinarians who didn't jump when the breeder said so. Ask those same veterinarians about those clients, and you'll hear about rude individuals, people who didn't pay their bills, and breeders who demanded services or treatments that the veterinarian felt would be detrimental to the animal's health.



There is a happy middle ground. Working at a veterinary clinic that draws reproductive clients from three states and having experienced breeder-owners on staff gives us a unique perspective. We believe that sharing what we have learned, both as veterinary personnel and as breeders, can help breeders develop a good relationship with their own veterinary clinic.

The key to finding a clinic experienced in helping breeders is to **do your homework**. Find a veterinarian before a crisis. Talk to other local breeders and find out who they use. Visit the sites for the Society for Theriogenology (therio.org) or the American College of Theriogenologists (theriogenology.com) for information on board-certified theriogenologists—veterinarians who specialize in reproductive medicine.

Decide on how you might use various veterinary hospitals in your area. Can you use the same clinic for routine care, emergencies, reproductive procedures, and health testing, or do you need to visit different clinics and veterinarians for these services? Find out who covers emergencies locally. Is your clinic available after hours, or would you need to go to a rotating-location or emergency-only clinic? Some clients travel long-distance to our clinic for services such as reproductive procedures, pre-breeding screenings, or complicated surgeries but use a closer clinic for routine exams, vaccinations, and minor issues.

Since it seems that breedings always need to happen on weekends and holidays (and puppies are whelped in the middle of the night), discuss the schedule and availability of the veterinarian(s) you will be working with. Doctors need time off, so you may not be able to always have your favorite veterinarian on hand. But if you have a working relationship with the clinic, this needn't be a problem. In addition, most veterinarians who "speak breeder" have support staff who are familiar with the needs and questions of breeders. It's helpful to know and cultivate these people.

**Plan ahead!** Be sure to discuss with the reproductive clinic or veterinarian what options will be available if you need assistance with a breeding or whelping. Forewarn them if you anticipate an AI or whelping over a weekend or holiday.

Additional questions that you might ask include:

What reproductive services do you offer?

Which doctor(s) and staff will I be working with?

What is the clinic's anesthesia and drug protocol for this procedure?

Is the staff experienced in performing C-sections?

If my bitch needs a C-section, will I be able to help rub down puppies?

Is a spay always performed at the time of a C-section? (Some clinics-especially those not used to working with responsible breeder-clients-make it a practice to spay any bitch presented for a C-section. This is fine in the case of a pet-quality bitch who was caught by a wandering male before the owners could have her spayed, but is not necessarily so fine with a bitch who is part of a breeding program.)

Is blood for transfusion available on-site? What about plasma for the puppies if they do not get colostrum from the dam? Discuss potential problems and what you would want to do.

# THIS COMMON CANCER IS THREE TIMES HIGHER IN DOGS THAN HUMANS

Approximately half of mammary tumors are malignant, says Dr. Carol Osborne, DVM, an integrative veterinarian in Chagrin Falls, Ohio, and half have metastasized by the time they are initially diagnosed. But she adds that prevention of mammary tumors is possible in many cases. Therefore, keep an eye (or better yet, a hand) out for a lump on your dog. If you come across something that seems suspicious, play it safe and do not wait to go to your vet. Once examined, a licensed veterinarian can perform a biopsy if she deems it necessary.

The prognosis — the likely outcome of the disease — depends on factors such as tumor size, how far the cancer has spread in the body, tumor type and grade, and other pathologic changes seen in the tumor tissue. According to Dr. Osborne, dogs can live several years after the complete removal of some malignant mammary tumors.

Female dogs who have not been spayed have a seven-fold increased risk of developing mammary cancer compared to neutered females. Dr. Osborne says that there is data that demonstrates the preventative benefits of spaying prior to the second heat cycle. As with so many other canine and human ailments, obesity also plays a role. Studies show that obesity at one year of age tripled the incidence of mammary cancer in non-spayed dogs.

Treatment: Treatment of a malignant tumor usually involves surgery. Similar to breast cancer in humans, dogs will either have just the tumor removed or the entire mammary tissue, along with lymph nodes. Dogs' mammary glands are different from humans in that they are outside of the muscle, so the surgery is not as radical. Unfortunately, unlike humans, chemotherapy and radiation in dogs are not successful, says Dr. Osborne. So once a mass is found, having surgery to remove it should happen as soon as possible. A healthy diet and supplements to boost the immune system have also proven to be very helpful.
